### Personal protective equipment

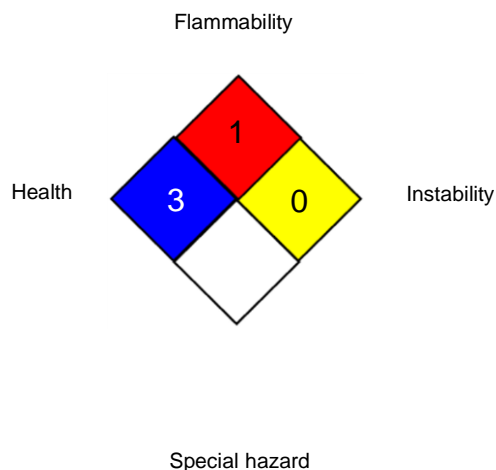
