Personal protective equipment

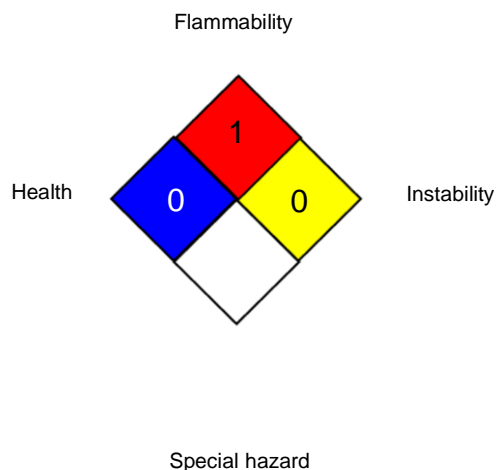
